Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office **Department of Environment, Babarmahal, Kathmandu** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon on 22<sup>th</sup> May, 2019**. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00 hours on 22<sup>th</sup> May, 2019.** at the office of Department of Environment, **Babarmahal, Kathmandu.** Bids must be valid for a period of 30 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 4,30,000/- which shall be valid for 30 days beyond the validity period of the bid **30<sup>th</sup> July, 2019.**
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
